Furthermore, I fully release and forever discharge the Association, its members, directors, officers, agents, employees and volunteers, and their insurers, from any and all liability of any nature, including the negligence of the Association, for any and all injury or damage (including death) to me and other persons as a result of my use of the Club, regardless of the cause and I agree to indemnify and hold harmless the Association, its members, directors, officers, agents, employees and volunteers, and their insurers, from any and all claims or causes of action brought against them that are in any way related to or arise from my use of the Club.

The foregoing concerns your legal rights and responsibilities. It is recommended that you consult legal counsel if the foregoing is not clear to you.

Membership Terms

All resident members shall have the option of paying for the full year in advance or monthly. Choosing monthly billing does not change the fact that the non-refundable commitment is for a full year. All new non-resident members must pay for a full membership year in advance. All memberships are non-refundable with the exceptions of death, divorce/separation or health.
